**SUBJECT:** Summer Food Service Program (SFSP), 2010 Reimbursement Rates

This memorandum informs all potential Sponsors of the SFSP of the annual adjustments to the SFSP reimbursement rates for meals served in the Program. SFSP sponsors will receive the maximum “meals times rates” operating and administrative reimbursements without regard to their actual costs. The 2010 reimbursements rates are presented as a combined set of rates to highlight the simplified cost accounting procedures and individually, as separate operating and administrative rates for reimbursement, to show the effect of the Consumer Price Index adjustment on each rate.
