### Definitions:

- **System Assigned Only** refers to risk codes that can only be assigned by Crossroads after information is entered. These risk codes are **NOT** available to the CPA for manual assignment on the Assigned Risk Factors screen.
- **CPA Assigned Only** refers to risk codes that require **manual assignment** by the CPA using the Assigned Risk Factors screen [Quick Entry or Select Risk Factors button].
- **System OR CPA Assigned** refers to risk codes that are assigned by Crossroads if the corresponding information that triggers the risk code is entered **OR**, these risk codes may be manually assigned by the CPA using the Assigned Risk Factors screen [Quick Entry or Select Risk Factors button].
